ALL MEALS AND SNACKS MEET USDA GUIDELINES FOR NUTRITION AND SANITATION. THE OBJECTIVE OF THIS PROGRAM IS THAT AT LEAST 80% OF BOYS IN ATTENDANCE EACH DAY WILL EAT A HEALTHY MEAL OR SNACK.
